## **Focal Theme:**

### 📖 Guidelines for Abstract Submission:

1. Abstract must be submitted in MS Word format.
2. All abstract must be submitted in **English**.
3. Abstract must be composed on 'normal page layout' selecting 'A4 page size'.
4. Abstract must be composed of **200-250 words** (without Title, Author's Essentials and keywords).
5. Abstract must be dignified by **4-5 key/ index words**.
6. **Text of the abstract** must be written with 'Times New Roman' front type having **12 front size** in **non-bold** and **non-italic** forms.
7. **Title of the paper/ manuscript** will be of **14-front size**.
8. **Text style** must be **normal** with **1.5 point line spacing**.
9. **No citation, references** and **graphics** should be included in the abstract composition.

10. **Restrictions from Plagiarism** alongwith **AI contents** must be **justified** under **editorial supervision**.
11. Abstract must be submitted **as per above mentioned deadline**. After notification or taking information from the reliable authority, accepted abstract sender will do their registration as per process. Otherwise, he/ she can complete their registration as a participant in the seminar.
12. **Full papers on only accepted and selected abstracts** will be considered as per paper submission guidelines. The opening and closing dates for full paper submission will be declared **after acceptance notification of the abstract**.

1. **Title:** A good brief title within **15 words (maximum)** having **14 point bold front size**
2. **Abstract:** Within **250 words** having **4-5 key/ index words**
3. **Word Limit of Full Paper:** **3000-5000 words**
4. **Page Layout:**
  - **Margin:** Normal
  - **Orientation:** Portrait
  - **Size:** A4
  - **Column:** Single
  - **Others:** No Watermark, no page colour, no page border
5. **Format (Front Type) of Text of the Manuscript/ Paper:** **Times New Roman**
6. **Front Size and Style:**
  - **Title:** 14 (Bold, but not italic)
  - **Abstract & Other Texts:** 12 (Not bold or italic excluding index or special terms)
  - **Point Title in the Body of Text:** 12 [Bold, but not italic and without colon (:) or hyphen (-)]
  - **Footnotes:** 11
7. **Line Spacing:** Normal
8. **Authorship:**
  - Entries can be co-authored, but limited to maximum three (3) per entry.
  - One author can be appeared maximum two times as one author and another co-author or two co-authors in maximum two papers in the abstract volume and also published book.
9. **Mode of Submission:**

- Abstract must be sent through prescribed **mail id only**.
  - **No hardcopy** for the same will be allowed.
10. **Submission Deadline:** Full paper submission must be done **as per declared deadline** from the reliable authority.
  11. **Plagiarism & AI Contents:**
    - **Plagiarism** must be restricted upto 20% of limit.
    - **AI contents** must be justified with proper AI Checker.
  12. **Review of the Paper/ Manuscript:**
    - Restricted '**Peer Review**' system must be done under the supervision of selected Editorial Board.
    - **Revision/ correction of the paper/ manuscript** must be considered as per **Review Report** from the allied Reviewer (s).
  13. **Publication Processing Charge:** A least amount of **publication processing charge** may/ must be considered for drawing the hardcopies of published book, certificate, etc.
  14. **Publication Authentication:** Seminar Organizing Committee must publish the book through reputed **national/ international level peer reviewed journal or publishing house/ company**.

### 📌 About the College

Bajkul Millani Mahavidyalaya (affiliated to Vidyasagar University) was re-accredited (3<sup>rd</sup> Cycle) with grade 'B+' (2.69) by NAAC in the year, 2024. Our college is one of the larger colleges in rural Bengal in terms of strength of students (about 4,400) and the number of subjects taught (18-Honours Disciplines & 23-General Disciplines) at the under graduate and recently post graduate levels (5-Regular

#### 📍 About the Department of Geography

The department started its journey in the session 1998 with only general course. But since 2000 when honours course was introduced, it entered in the mainstream of the college. Gloriously the PG department has been introduced in 2016. Today, our department is not only an integral part and leading one UG and PG department of Bajkul Milani Mahavidyalaya, undoubtedly, the department has been emerged as one of the most well equipped and well placed undergraduate and post graduate department of Vidyasagar University. Within only sixteen years' journey, the department has managed to possess all kinds of conventional and modern instruments and a high quality department library with more than seven hundred books on subject and all the related disciplines and sub-disciplines. Not only that, our department is mostly popular because of maintaining the rules and regulations, providing the technical and smart class system, conducting the different character building cultural and career counseling programmes, arranging the inter-disciplinary, regional, state level and national level seminars and such type of knowledge enriched programmes and extraordinary keenness bonding students, alumni and staff. The department already has two full time teachers (1 Associate Professor & 1 Assistant Professor), twelve State Aided College Teachers (10 SACT-I & II) and two permanent non-teaching staff. So in terms of students' support, it has emerged as one of the best in the region. So far, thirteen batches of students have been passed out and many of them

are well placed in academic and research fields in various schools, colleges and universities around the country. All the teachers of the department are actively engaged in research and contributed about thirty research papers in various journals of repute. Overall, it may be said that our department is heartily trying to be good lover and follower as well as survivor of this subject, Geography with its effortless and evergreen journey on the most dynamic, but versatile geo-environmental track.

#### 📍 About the Department of Zoology

The Department of Zoology was established in 1995 with General courses, followed by the introduction of Honours courses in 1998-99. Since then, it has maintained a strong academic record under Vidyasagar University, with alumni contributing to reputed research institutes and diverse professions. Currently, the department comprises two permanent assistant professors (one Ph.D. holder, another pursuing Ph.D.) and seven SACT-II teachers, of whom two are also enrolled in Ph.D. programmes. Faculty members are actively involved in research, social work, NSS, projects, and surveys. The department fosters a close-knit environment where learning extends beyond classrooms.

It is equipped with two advanced laboratories, a departmental museum with rare specimens, and a well-stocked library. Teaching-learning activities include PowerPoint presentations, quizzes, class tests, tutorials, remedial classes, mock entrance tests, and guest lectures from resource persons. Annual field trips, seminars, workshops, and group discussions enhance practical knowledge and skills. Students also publish an annual wall magazine, organize cultural and academic events like Teachers' Day, farewells, and welcomes.

The department is active in biodiversity conservation through membership in the Biodiversity Management Committee of Bhagwanpur I Block, People's Biodiversity Register work under WBBB, animal rescue, and public awareness campaigns. It has signed MoUs with Lokmata Rani Rasmani Mission and Mahishadal Raj College, ensuring collaborative programmes. An add-on course in Wildlife and Biodiversity Conservation began in 2021, and four webinars were organized during the COVID-19 period.

Beyond academics, the department encourages self-employment and entrepreneurship in areas like pisciculture, poultry farming, vermicomposting, and beekeeping.
